### Regulation 48 – in brief

#### **Regulation 48 revision 3** (Reg.48-03)

This is the regulation for installation of lighting and signalling. NEW in revision 3 is that retroreflective markings according to ECE104 are now mandatory for any new EU type approvals for trucks 7.5 tons and above (N2 and N3) and trailers 3.5 tons and above (O3 and O4). This means that any vehicle of this type sold into countries automatically adopting R.48 rev.3 will need to have ECE104 approved markings. Regulation 48 rev.3 was published in October 2006 and has a transitional period of 12 months.



#### ECE104

European regulation for retroreflective markings of HGVs. Markings to comply with Regulation 48.

#### Directive 76/756/ECC

This directive makes EU type approvals mandatory, and means that all 27 EU countries must adopt the revision 3 of Regulation 48.

#### **ECWVTA 70/156**

Directive 70/156 is the European Whole Vehicle Type Approval (ECWVTA). This will allow any OEM to get a whole type approval for their vehicle to be used in the EU. It means that a vehicle homologated in one country with a European Type approval can be sold everywhere in the EU without requiring any additional national type approval.
